Data collection procedure (link to protocol, questionnaire etc.)	The objective constitutes a policy and legal analysis. Hence, there is no questionnaire or data collection protocol. This document only describes the legal sources as the foundational sources for analysis (in addition applicable policies are selected). As far as the legal studies are concerned, mainly legal sources at the national Swedish level have been selected, as questions relating to land use are largely outside the EU's legislative competence. The influence of EU law is therefore limited to issues relating to area and species protection.
Variable names	The legal analysis takes its point of departure in the doctrine of legal sources, which means that legal sources of different dignity are analyzed to determine the applicable law, i.e. how the legal system contributes to controlling the use of natural resources.
